

Taxation of Interest on EPF Contribution Exceeding Rs 2.5 lakh: An overview

One morning, Mr. Gautam picked up the phone to speak with his trusted friend Hari, a Chartered Accountant renowned for his financial expertise. "Hey Hari," he began, a hint of confusion in his voice, "As I was getting ready to file my Income Tax Return with the Form 16 from my employer, I noticed an additional TDS credit from the EPF Organization. What's going on? I thought my contributions to EPF were exempt!"

Hari paused for a moment, processing Gautam's question. "Did you end up contributing more than ₹2.5 lakhs to your EPF last year?" he asked, sparking a realisation in Gautam.

"Ah, yes! I believe I contributed around ₹4 lakhs," Gautam admitted

"Exactly," Hari confirmed. "That's the reason for the TDS deduction. You see, since 2021, any interest earned on contributions exceeding ₹2.5 lakhs is considered taxable in your bands m's curiosity deepened. "But if that's the case, why didn't my employer deduct the full tax on this interest when processing my salary? Can you clarify how this interest became taxable? And what happens when I eventually withdraw my accumulated balance? Will it be taxed again?"

With a steady and reassuring tone, Hari responded, "Don't worry, Gautam. I'll break it down for you step by step." He launched into a thorough explanation guiding his friend through the complexities of the tax world.

Employee Provident Fund

The Employee Provident Fund (EPF) is a retirement benefits scheme designed for salaried employees in India, governed by the Employees Provident Fund Organisation (EPFO). All factories or organisations ons with 20 or more employees are required to register under the EPFO, though some smaller organisations may choose to register voluntarily.

Employee and Employer Contributions:

Employees are required to contribute ₹1,800 or 12% of their basic salary plus dearness allowance (DA), whichever is lower. It's common for companies to deduct this 12% from an employee's salary. The employer also contributes an equivalent amount to the EPF. It is interesting to note that the definition of salary which is taxed excludes employer's contribution to EPF upto 12%, which means this is an exempt income.

Employees wishing to contribute more may opt for the Voluntary Provident Fund (VPF), where they can voluntarily enhance their monthly contribution but the employers are not required to match contributions that exceed 12% of the basic salary + DA.

Interest on PF contributions is credited annually at the end of each financial year. For FY 2023-24, the EPF interest rate is set at 8.25%. After retirement, employees will receive a lump sum amount that includes their own contributions, their employer's contributions, and the interest accrued on both.



Every employee, including both regular and contractual workers, earning a monthly wage of up to ₹15,000, must be enrolled in the EPF by their employer. For employees with a salary exceeding ₹15,000 who wish to contribute to the EPF, they can do so only with their employer's consent.



Calculating Taxable Interest

As per notification No. 95/2021, the EPFO will maintain separate accounts for taxable and non-taxable contributions for all EPF subscribers from FY 2021-22 onwards. Taxable interest will be calculated based on contributions surpassing the threshold limit, and TDS will be deducted on these amounts.

TDS Deduction on Interest

TDS on taxable interest will be deducted under scenarios such as:

- Annual processing of interest in EPFO accounts
- PF payments during the financial year for outgoing members
- Transfer claims for moving funds between EPFO and exempt establishments

The TDS on taxable interest on the PF account shall be deducted as per Section 194A of the Income Tax Act. The law states that the payer of the income should deduct TDS. Hence, the payer of interest on the PF account is the provident fund department and not the employer. Therefore, TDS will be deducted by EPFO and deposited to the government. Further, the EPFO will issue Form 16A for the same.

TDS will be deducted at 10% for taxable interest income that exceeds ₹5,000 for resident Indians. In cases where TDS is deducted, employees are responsible for adding this taxable interest to their income and calculating taxes accordingly, and credits for TDS can be claimed by the employees.

No TDS will be applicable on past accumulation till 31st March 2021. It will be applicable to contributions made from 1st April 2021, which exceed the threshold limit of Rs 2.5 lakh.

If PF account is not linked with PAN, then the TDS rate will double to 20%.

Employee and Employer Contributions

After retirement, employees will receive a lump sum amount that includes their own contributions, their employer's contributions, and the interest accrued on both.

Taxation Rules for EPF Contributions

Following the Budget 2021, any interest accrued on an employee's EPF contributions exceeding ₹2.5 lakh in a financial year is subject to taxation. Also from FY 2020-21 onwards, the employer's contribution to the EPF account shall become taxable if the contribution to EPF, NPS and/or superannuation fund exceeds Rs 7.5 lakh in a financial year. This has plugged the loophole where blanket exemption was given to employer's contribution upto 12% of salary irrespective of the amount.

Additionally, since FY 2020-21, any employer contributions exceeding ₹7.5 lakh in a financial year are taxable.

Under Section 80C of the Income Tax Act, employees can claim a deduction for EPF contributions up to ₹1.5 lakh.



Example:

Consider an employee with a basic salary of ₹50,000 per month. The employer deducts ₹6,000 (12% of the basic salary) as EPF contributions. If the employee contributes ₹3.28 lakh to the VPF during the year, the total contribution would be ₹4 lakh (i.e., ₹6,000 x 12 months + ₹3.28 lakh). The employee would then need to pay taxes on interest earned from the excess contribution of ₹1.5 lakh.(4 lakh – 2.5 lakh)

For government employees contributing to the General Provident Fund (GPF), the threshold for taxable interest is raised to ₹5 lakh.




