

#### GTA

The definition of Goods Transport Agency under GST laws is provided in clause (ze) of notification no.12/2017-Central Tax (Rate) dated 28.06.2017,"Goods transport agency means any person who provides services in relation to transportation of goods by road & issues consignment note". Others may also hire out vehicles for goods transportation, only those issuing a consignment note shall be considered as GTA under the provisions of GST.

#### **CONSIGNMENT NOTE**

<sup>'</sup>Consignment Note is neither defined in the Act nor in the notification no.12/2017-Central Tax (Rate).

Guidance can be taken from the meaning to the term under the Explanation to Rule 4B of Service Tax Rules, 1994.

""A document issued by GTA Against the receipt of goods for the purpose of delivery of goods by road in a goods carriage which is serially numbered, and contains the name of the consignor and consignee, registration number of the goods carriage in which the goods are transported, details of the goods transported, details of the place of origin and destination, person liable for paying service tax whether consignor, consignee or the goods transport agency."

If a consignment note is issued, it means that the lien on the goods has been transferred to GTA and now GTA is responsible for the goods to the consignee. Services Provided by GTA.

- a)Transportation of goods by road
- b)Loading/Unloading
- c)Packing/Non packing
- d)Trans-shipment
- e)Temporary Warehousing..etc

If the ancillary services referred to in (b) to (e) is to be included in the value of supply of services provided by GTA referred to in(a) then those services, should form part of composite supply referred to insection 2(30) of CGST ACT.

#### IS GTA LIABLE TO GET REGISTERED?


Generally as per the provisions of section 22 of CGST ACT, 2017

(1) Every supplier shall be liable to be registered under this Act in the State or Union territory, other than special category States, from where he makes a taxable supply of goods or services or both, if his aggregate turnover in a financial year exceeds twenty lakh rupees:

Provided that where such person makes taxable supplies of goods or services or both from any of the special category States, he shall be liable to be registered if his aggregate turnover in a financial year exceeds ten lakh rupees.

Explanation.—For the purposes of this section,— (i) the expression "aggregate turnover" shall include all supplies made by the taxable person, whether on his own account or made on behalf of all his principals; (ii) the supply of goods, after completion of job work, by a registered job worker shall be treated as the supply of goods by the principal referred to in section 143, and the value of such goods shall not be included in the aggregate turnover of the registered job worker; (iii) the expression "special category States" shall mean the States as specified in subclause (g) of clause (4) of article 279A of the Constitution.

As per Notification No. 5/2017—Central Tax, dated 19.06.2017 the Central Government hereby specifies the persons who are only engaged in making supplies of taxable goods or services or both, the total tax on which is liable to be paid on reverse charge basis by the recipient of such goods or services or both under sub-section (3) of section 9 of the said Act as the category of persons exempted from obtaining registration under the aforesaid Act.



Any factory registered under or governed by the Factories Act, 1948(63 of 1948)

Society (Registered under Societies ACT)

Any co-operative society ,established under any law

Any person registered under the Central Goods and Services Tax Act or the Integrated Goods and Services Tax Act or the State Goods and Services Tax Act or the Union Territory Goods and Services Tax Act

Any body corporate established, by or under any law

Any partnership firm whether registered or not under any law ncluding association of persons
Any Casual Taxable Person

#### **EXEMPTIONS**

Services provided by GTA to an unregistered person (including unregistered casual taxable person are exempt from GST by virtue of ENTRY 21A.oFurther, GTA services provided to registered Casual Taxable persons and following persons, even if unregistered under GST law are liable to tax.

- 'Factory registered under factories Act
- 'Society registered under societies ACT,
- 'Co-operative society
- 'Body Corporate
- Partnership firm including Association of persons

Following goods transported by GTA is exempted.

- 1. Agricultural produce.
- 2. Milk, Salt& Food grains including flour, pulses &rice.
- 3. Defense/Military equipment.
- 4. Newspapers/Magazines registered with the registrar of newspaper.
- 5. Relief materials meant for victims of natural or man-made disasters, calamities, accidents or mishaps.
- 6. Goods where consideration charged for the transportation of goods on a consignment transported in a single carriage does not exceed Rs.1500.

7.Goods, whereconsideration charged for transportation of all such goods for a singleconsignee does not exceed rs.750.

#### As per entry 21 B

Services provided by GTA by way of transport of goods in a goods carriage to

- i]Department/Establishment of Central Government Stategovernment/Union territtory
- ii Local Authority
- iii]Government agencies

which has taken registration under CGST ACT only for the purpose of deducting tax under section 51 and not for making any taxable supplies of Goods or Services or Both.
