

Now we are dreaming of becoming the third largest economy in the world by 2030. But what is the reality? According to the latest Financial Stability Report released by the Reserve Bank of India (RBI) "the Indian economy and the domestic financial system remain resilient, supported by strong macroeconomic fundamentals, healthy balance sheets of financial institutions, moderating inflation, improving external sector position and continuing fiscal consolidation."

Even though many organisations like the International Monetary Fund (IMF) have applauded India for being the fastest growing economy, as per the India Employment report 2024 released by the International Labour Organisation (ILO) the total unemployed youth has almost doubled from 35.2% in 2000 to 65.7% in 2022. There has been no significant growth of real wages in India since 2014, according to numbers computed by noted developmental economist Jean Dreze.



A governance which gives paramount position to the value system is important for achieving big dreams. Good governance is indeed important but it is the people who are the roots of the same. For achieving a stellar performance, it is important to have a scrupulous society and administrators with integrity.

A new government will come in the month of June 2024. It can be anyone but the collective aim of the people of this great nation should be to become a strong economy and let our country be successful in achieving her Mission 2030.



# HOW DID ARTIFICIAL INTELLIGENCE APPEAR IN THE STOCK MARKET?



#### **Algo Trading**

Nowadays, the vast majority of financial transactions are conducted electronically, and the time it takes to complete a stock exchange has been shaved down to mere nanoseconds.

Trading Algo Buying or selling securities in accordance with a predetermined set of guidelines that have been tested on previous or historical data is known as algorithmic trading.

### The Emergence of AI in Stock Market Dynamics

The introduction of the internet and the ensuing advancements in technology have had a profound impact on how stock markets operate and, in turn, how securities are actively traded. The two most significant technical advancements, according to a Journal of Finance article, are:

- 1. Financial investors are using computer systems to automate their stock trading procedures;
- 2. The financial markets have reorganised, resulting in the virtual elimination of all markets except order books at this time.

These sets of guidelines are predicated on technical analysis, indicators, charts, and stock fundamentals. Let's take an example where you have an offer to buy a stock, and you anticipate that the stock would lose money for three days in a row before it starts to gain value. In this situation, an algorithm can be written and designed so that the buy order for that specific stock is fulfilled at a predetermined low price and sold at a certain high price.

The use of algorithms in trading has grown dramatically in the last ten years. Approximately 70% of the total trading volume on the American stock market is started by algorithmic trading. Grand View Research estimates that the global market for algorithmic trading was worth USD 15.55 billion in 2021 and will rise at a compound annual growth rate (CAGR) of 12.2% between 2022 and 2030.





#### **High Frequency Trading**

High-frequency trading algorithmic common use of trading (HFT). The majority of regulators and ordinary stock market investors are currently leaning toward **HFT** and algorithmic trading. Within the type of algorithmic trading known as HFT, large quantities of equities and shares are mechanically bought and sold at extremely fast speeds. Future trends indicate that HFT will emerge as the most reputable type of algorithmic trading. lt tends to evolve constantly.

Trading has changed as a result of algorithmic trading. Algorithms are being used by stock traders to increase trading speed efficiency. Since artificial will allow intelligence (AI) algorithms to adapt to a variety of patterns, they trading inevitably get more complex.

Additionally, we should expect algo trading to advance toward more practical machine learning (ML) skills that can handle the real-time interpretation of massive amounts of data from numerous sources.

Machine learning (ML) is a branch of computer science that uses techniques and models from many different fields, including control theory, artificial intelligence, computational complexity, algorithms, and statistics. It is naturally suited for application to HFT problems pertaining to trade execution and alpha generation, as its main focus is on informationally and computationally efficient algorithms for inferring good predictive models from large data sets (performance of asset or portfolio of assets). Thus, Al trading may be characterized as the fruitful combination of algorithmic trading with machine learning.
