EQUALISATION LEVY SCHEME IN INDIA

A Short Brief

There was a great need of the time following the era of digitalisation in India during the last decade, as use of smart phones have increased to a significant extent, which in turn have rapidly increased the promotional and advertising activities through digital modes like various business and corporate houses, start-ups in India has started promoting their products and services digitally through Facebook, Instagram, YouTube and various other applications, the server of which are located outside India. The biggest challenge before the Income tax authorities was that they cannot tax such income as business was conducted without regard to national boundaries and may dissolve the link between an income producing activity and a specific location. In digital Domain the business doesn't occur in any physical location but instead takes place in cyberspace due to which it becomes difficult to determine the taxability of Income.

To overcome this situation and to protect the interest of revenue the Central Government of India has introduced the concept of Equalization levy Scheme vide VIII Chapter in the Finance Act, 2016 with effect from 1st June 2016 to whole of India except Jammu and Kashmir. The Idea of this levy was taken from BEPS Action plan 1, which provides 3 recommendations out of which India has implemented 2 recommendations i.e. equalization levy and significant economic presence concept.

But what actually equalization levy means and to whom it is applicable ? Lets understand more analytically through the wordings of bare text;

Meaning of Equalization levy: Equalization Levy means the tax leviable on consideration received or receivable for any specifies service.

What is specified service?

i). Online Advertisement;

ii). Any provision for digital advertising space or any other facility or service for the purpose of online advertisement or any other service as may be notified by the central government in near future.

Charge of levy (Section 165 of Finance Act,2016 is the charging section)



Equalization levy is levied at the rate of 6% on the amount of consideration for specified service (as mentioned above) received or receivable by a person, being non-resident from-

- (a) A person resident in India and carrying on business or profession or
- (b) A non-resident having a Permanent Establishment in India.

Equalization levy is not chargeable, where-

- (a) The non-resident providing the specified service has a permanent establishment in India and the specified service is effectively connected with such permanent establishment;
- (b) The aggregate amount of consideration for specified service received or receivable in a previous year by the non-resident from a person resident in India and carrying on business or profession, or from a non-resident having a permanent establishment in India, does not exceed INR 1 lakh or
- (c) Where the payment for the specified service by the person resident in India or the PE in India is not for the purposes of carrying out business or profession.

Conclusion: The introduction of such tax regime proves to be boon for the Indian Economy as it helps in increasing the tax revenue of the nation and to have a check and control over the payments made to such E-commerce companies which are not having permanent establishment or place of business in India.

COVID 19 AND VACCINE

- **How vaccines work with our body to protect us?**

Vaccines, what they do is they are a part of the germ that our body can recognize and develop an immune response to so that the next time that we see the real germ, there are already fighters in our body to protect us against the infection. And the fighters that I'm speaking about, those are called antibodies. It's the part of our immune system that is the part that can attack that particular part of the virus

- **When we hear about vaccines, people may have questions about safety. Speak to us about safety of these vaccines**

Our immune systems are incredibly powerful. On a daily basis, a weekly basis, a monthly basis, our immune systems are seeing all kinds of viruses that come at us in our noses, in our mouths, in our intestinal track on our hands. What the vaccines do is they provide to the immune system a small part of a germ that we know can cause disease. And it's training the immune system so that it is completely ready when it actually sees that particular germ. The vaccines that we have, has been studied, evaluated for safety and for the impact that they have. So, I think we can be really well assured that we have a very strong system in place to both look at safety, assure safety, before a vaccine is authorized for use and will continue to monitor safety even after it is deployed for widespread use.



- **We're hearing about variants of the SARS-CoV-2 virus that causes COVID-19. And do these vaccines protect us from these variants? And is this something that is kept in mind when vaccines are being manufactured?**

Yes, this is a very important point that vaccine developers keep in mind. And as you know, we have some vaccines, like measles, which you don't need to change at all. You make the vaccine, it works pretty much all the time. Now for SARS-CoV-2 we're still learning, we're still observing and our knowledge is evolving. But at this point in time, most scientists believe that the vaccines that are currently in development and a couple that have been approved should provide protection against this variant and other variants. And so a couple of changes or mutations in the virus should not make these vaccines ineffective. Nowadays the way vaccines are developed, it will be possible actually to also change the composition of the antigens and the vaccines quite quickly.

- **After one has been vaccinated, when does the immunity kick in and how long does it last?**

The vaccines that we have right now are all two-dose vaccines. After the first dose, we see a good immune response that kicks in within about two weeks of that first dose. And it's really the second dose that then boosts that immune response and we see immunity get even stronger after that second dose, again within a shorter period of time after the second dose.



We don't know yet how long immunity lasts from the vaccines that we have at hand right now. We're following people who have received vaccinations to find out whether or not their immune response is durable over time and the length of time for which they're protected against disease.

- **How much time there should be between the two doses? And what if we can't make it to my second dose? Or what if we miss second dose altogether?**

Most of the vaccines that are being developed need at least two doses, but there are some single dose vaccine candidates as well. The interval between the doses depends on which vaccine you're getting and most of those vaccines currently are being given between three to four weeks between the first and the second dose. But there is some data from some vaccines like the AstraZeneca vaccine, where delaying the second dose up to 12 weeks actually gives a better immune boost. Now, in terms of missing the second dose or being delayed, it's important to get the second dose if the vaccine is a two dose schedule. It doesn't matter if it's early by a few days or late by a few days or even a couple of weeks. It's important to go back and get that

second dose because the first dose actually presents this new antigen to the immune system to prime it. And the second dose is the one that really gives a boost to the immune system so that the antibody response, they are very strong and they also develop a memory response, which then lasts for a long time, so that when the body sees this antigen again, this virus protein again, it knows that it needs to react quickly.

- **Can these two doses be from two different manufacturers?**



Again, the science is changing and evolving and the knowledge base is growing. There are now clinical trials ongoing in some countries that are looking at interchangeability, which means the first dose with one vaccine and the second dose with a different vaccine, maybe even a different platform vaccine. And immunologically, there are reasons why this would make sense. However, at the present time, there isn't enough data for us to recommend this type of interchangeable two dose schedules. And so for the time being, the policy advice that WHO has put out is reviewing the data from the other vaccines that are in the pipeline. And for the time being, it is recommended to have the second dose with the same vaccine as you had the first dose.

- **Why does one need to continue with the precautions even after vaccination? And, how long are we expected to take these precautions?**

So, we really need to continue these precautions while we're still learning about what the vaccines can do. And right now, we're in a situation where there's still very broad transmission in many countries, the transmission is just out of control. And so for how long we need to continue these precautions is really going to depend on what communities and countries can do to really crush this virus. In turn, the vaccines can do their best job at preventing disease. The second reason is that the vaccines are in short supply, we don't have enough vaccine yet out in the community to protect everybody. Those are the reasons why we have to continue the precautions, the masking, the physical distancing, the hand washing and not gathering in big groups. Once we get broad vaccination coverage, when we know more about what the vaccine can actually do to prevent infection, and we can slowly start taking our foot off the pedal of these other interventions and make sure that the transmission, again, doesn't start to escalate again.



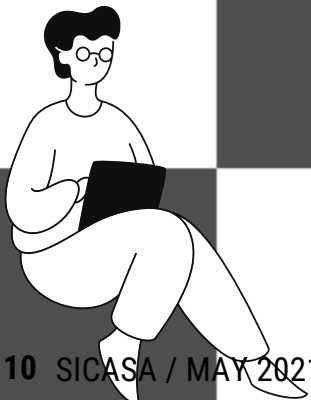
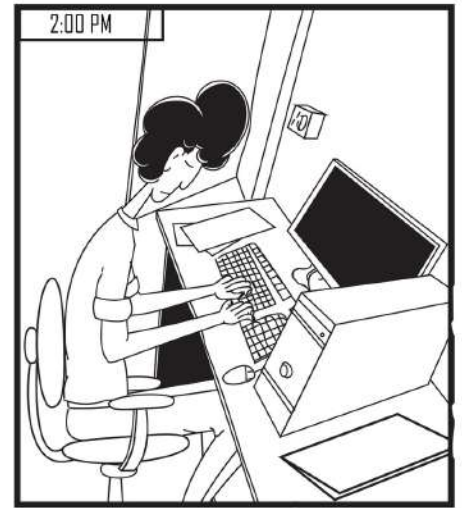

TIME

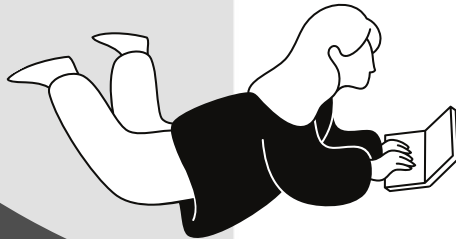
Amidst the solid summer rain,

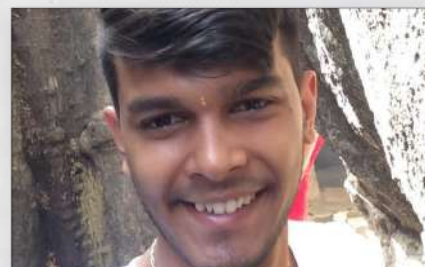

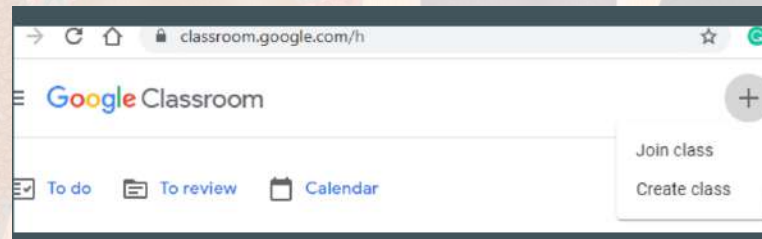
