

Brain Teaser: The Mysterious Elevator Puzzle

You work in a 100-floor building, and the elevators are notoriously slow. To make things worse, you just discovered a strange quirk: one of the elevators only stops at floors that are prime numbers!

Here's the puzzle: You're on the 1st floor, and you need to reach the 100th floor as quickly as possible, but you can only use the prime-floor-stopping elevator. You want to figure out a path that minimizes the number of stops you need to make, given the prime-number limitation.

This puzzle requires logical thinking, familiarity with prime numbers, and the ability to plan an optimal path.


Answer:

The minimum number of stops needed to reach the 100th floor is 4 stops, and the optimal path is via floors 2, 19, 43, and 97.
